2. The Allocation of stalls will be on first come first basis.
3. The size of the each Stall is 3x3 = 9Sq.Mts.
4. The Booth Rental Fee includes 01 Table, 02 Chairs, 01, 5/15 A Plug point, 03 Spot Lights, Fascia Name and waste paper basket, Additional requirements will be charged extra.
5. Two Complimentary Registrations for each stall.
6. All prices exclusive of 18% GST (As applicable)
7. Sponsorship / Exhibition will be allocated on first cum first serve basis only after the draft for the booking amount is deposited / en – cashed and the Organizers reserve the right to cancel the booking in the event of nonpayment within the stipulated time. Please note that all payments must be made in Indian Rupees through Demand Draft NEFT / RTGS to the Conference account.
8. Priority for space assignments will be made on a first-come, first-serve basis. Taking space configurations under consideration, the managing committee reserves the right to make any revisions necessary to the floor plan.
9. The Exhibition committee reserves the right to modify or rearrange the floor plan or even cancel any sponsorship / Exhibitor without any Reason there of.
10. All booking forms (**Trade Form D**) must be accompanied by 50% advance at the time of Reservation and the remaining 50% must be paid on or before 30th Nov 2025 Written confirmation of booking will be given after 100% advance payment.
11. Microphone or any promotional activities, hindering or disturbing other sponsor/exhibitor will not be permitted. This is must for security purpose. The number of representatives of the sponsor/exhibitor at the conference venue will be limited, depending on the extent of sponsorship, at the discretion of the organizing committee.
